

Do you have any natural fur products in your house or in one of the household members' wardrobe (coat, jacket collar, hat, key chain, cushion cover, boots...)?







Personally, do you like natural fur ?

Have you ever considered buying a natural fur product of any kind...








Intention to buy natural fur products - gender





Importance of the level of information for the acceptability of fur-farming


Do you find acceptable breeding animals for their fur ?






Have you ever visited a fur farm ?





Perception of animal breeding for various purposes






